### **Required Annual UCC4A Disclosure**

UCC4A Disclosures must be provided to any member or business receiving or originating Cash Concentration or Disbursement (CCD) and Corporate Trade Exchange (CTX) credit entries via the ACH Network (Reference 2008 ACH Rules Ref(s): Article 2.1.10, Notice by ODFI, and Article 2.1.11, Notice by RDFI, page OR 4).

#### **Provisional Payment Disclosure**

Credit given by us (Guthrie Federal Credit Union) to you (credit union member) with respect to an Automated Clearing House credit entry is provisional until we receive final settlement for such entry through a Federal Reserve Bank. If we do not receive such final settlement, you are hereby notified and agree that we are entitled to a refund of the amount credited to you in connection with such entry, and the party making payment to you via such entry (i.e., the originator of the entry) shall not be deemed to have paid you in the amount of such entry.

#### **Notice Disclosure**

Under the operating rules of the National Automated Clearing House Association, which are applicable to ACH transactions involving your account, we are not required to give next-day notice to you of receipt of an ACH item, and we will not do so. However, we will continue to notify you of the receipt of payments in the periodic statements we provide to you.

#### **Choice of Law Disclosure**

We may accept on your behalf payments to your account that have been transmitted through one or more Automated Clearing Houses (ACH) and that are not subject to the Electronic Fund Transfer Act, and your rights and obligations with respect to such payments shall be construed in accordance with and governed by the laws of the state of Pennsylvania as provided by the operating rules of the National Automated Clearing House Association, which are applicable to ACH transactions involving your account.

# President's Message

I am happy to report that our membership base continues to grow, and the credit union continues to operate in a safe and secure manner as evidenced by our "Well **Capitalized**" rating as defined by the National Credit Union Administration guidelines. The credit union's net worth position grew from 11.04% at December 31, 2017, to 11.89% as of December 31, 2018.

The credit union's financial position continued to improve as assets have grown from \$72.3 million as of December 2017 to \$73.8 million as of December 31, 2018. Deposits have reached \$64.8 million as we now serve over 7,298 members who rely on our credit union for safety and soundness.

As interest rates climbed during 2018, we kept our loan rates low and competitive as exhibited by the growth in loan originations, which were up by \$736,000 for year-end 2018. We also priced our deposits competitively by increasing money market rates and offering the members several certificate of deposit specials through year end.

During the first quarter of 2018, we made several equipment upgrades, including new ATMs at the 104 N. Elmer walk-up, the Bird Summer lobby of the Guthrie Clinic in Sayre, Pennsylvania, and the Guthrie Towanda Memorial Hospital. Additional upgrades are planned for 2019. On June 1 of this past year, we introduced our new check ordering company. Guthrie FCU partnered with Check Printing Solutions to save you money when ordering checks, checkbook covers and other banking supplies.

During the third and fourth quarters of 2018, we started the planning and implementation phase of our new digital wallet solutions to include Apple Pay® and Samsung<sup>®</sup> Pay. Apple Pay and Samsung Pay are both a safer and easier way to complete transactions and offer several unique security features. Both are now in their testing phases with an implementation date slated for the second guarter of 2019.

The biggest news of 2018 was the approval of our community charter expansion application from NCUA. The expansion, which was approved on August 7, 2018, allows GFCU to offer membership to anyone who lives, worships, works (or regularly conducts business) or attends school, a business or another legal entity in Tompkins, Schuyler, Tioga, Chemung or Steuben Counties in New York, Bradford or Tioga Counties in Pennsylvania.

I would like to take this opportunity to thank our talented staff, who take great pride and dedication in providing you with the highest level of service possible. The success of GFCU is a result of our loyal members and the service of outstanding, competent and hard-working employees and volunteers. We wish you a safe and enjoyable spring!

# GFCU Board of Directors Elections and Annual Meeting Notice

The Guthrie Federal Credit Union Annual Meeting for 2018 will be held Saturday, **March 23, 2019**, at 5:00 p.m. The meeting will be held at the Best Western Hotels & Resorts located at 255 Spring St., Sayre, PA.

All GFCU members are welcome to attend. Please see a GFCU representative to make your reservation if you wish to attend.

There will be no election for the three available positions on the Guthrie Federal Credit Union Board of Directors. The Nominating Committee submitted three candidates, and they were posted in both GFCU branch office locations in Sayre and Troy. At that time, members interested in serving on the GFCU Board of Directors were invited to submit petitions for inclusion on the ballot. The deadline for these submissions was January 2, 2019. Since no petitions were received by the deadline, and the Nominating Committee had already submitted the three incumbent candidates for the three vacant positions, there will be no voting at this year's annual meeting. In lieu of elections, the Nomination Chairperson will request that the Secretary cast one ballot for the slate of officers as presented at the annual meeting.

**Bernie Smith** – Mr. Smith graduated in 1975 from Waynesburg College, receiving a bachelor's degree in accounting and business administration. Mr. Smith recently retired, spending the last 40 years working in the accounting and finance field, the last 19 years with Guthrie Healthcare. Mr. Smith started his career with the Pennsylvania & Southern Gas in 1975 and joined The Guthrie System in 1997. He has been a member of the Guthrie Federal Credit Union board for 18 years and has served both on the Finance, Supervisory and Personnel Committees for the credit union. John Simonds – Mr. Simonds currently serves as the Vice President of Human Resources for Pathways, Inc. in Corning, NY, and has been employed there for the past 18 years. A graduate of the University of Scranton, Mr. Simonds has served on the Guthrie Federal Credit Union Board for 12 years and served on the Personnel Committee for the credit union.
